Course Description

AI for Communication with Parents is a hands-on course designed to unlock the power of next-generation technology to transform how you connect with your students' families using free AI tools. This online course is designed specifically for educators looking to streamline correspondence while elevating the quality of every interaction. Whether you are a tech enthusiast or completely new to using AI in education, this course is for you.

You will learn to use the user-friendly AI teaching assistants, Brisk Teaching and MagicSchool, to draft professional emails, newsletters, FAQs, and instant messages, yielding ready-to-use resources. The focus is on ensuring your digital communications maintain a high standard of professionalism, empathy, and clarity to facilitate consistent communication. Additionally, you'll master multilingual translation tools to bridge language gaps and ensure every family is included in their child's education.

Through engaging online resources, video tutorials, activities, course resources, and assignments, you will learn to:

- Harness the power of AI with well-engineered writing prompts.
- Navigate sensitive conversations with AI support to maintain a supportive tone.
- Personalize messages at scale without increasing your daily workload.
- Use language-learning models, including ChatGPT, Google Gemini, and Microsoft Copilot, for brainstorming, content generation, resource development, tutorials, and related tasks.

This is a standalone course within the AI Flash Innovative Course Series. No prerequisite knowledge or prior enrollment in other AI Flash courses is required. Access to or interaction with students is not necessary for successful course completion or mastery of the course objectives.

Note: There is no required book for this course.

Required Texts and Course Materials

Canvas: This course will be delivered totally online. Canvas is a web-based learning management system (LMS) that provides students access to online resources, documents, videos, assignments, quizzes, forums, etc. Canvas is easy to learn and has a user-friendly interface.

Online Resources: Relevant online resources that support the course content and encourage further investigation will be available throughout the course assignments. Active hyperlinks are used throughout the course and will direct users to the appropriate information when clicked. These include videos, podcasts, worksheets, online activities, journal articles, and other resources. All resources used in this course are free.

Course Dates

Self-paced; students must enroll during the 2-week registration window and complete the course and post all assignments within the 6 to 8-week course completion window. Students may not complete assignments in less than 1 week for a 1-unit course (1 week per unit) per university policy.

Grading Policies

- Assignments will be graded per criteria presented in the course rubrics.
- A = 90-100% and B = 80-89%, (anything below 80% will not receive credit.)
- The discernment between an A or a B letter grade is at the discretion of the instructor based on the quality of work submitted (see course rubrics).
- Coursework falling below a B grade will be returned with further instructions.
- All assignments must be completed to receive a grade and are expected to reflect the quality that teacher-training institutions require of professional educators. If completed assignments do not meet this standard, students will be notified with further instructions from the instructor.

Writing Requirements

- **Superior:** Writing is clear, succinct, and reflects graduate level expectations. Clearly addresses all parts of the writing task. Maintains a consistent point of view and organizational structure. Includes relevant facts, details, and explanations.
- **Standard:** Writing is acceptable with very few mistakes in grammar and spelling. Addresses most parts of the writing task. Maintains a mostly consistent point of view and organizational structure. Includes mostly relevant facts, details, and explanations.
- **Sub-standard:** Writing contains noticeable mistakes in grammar and spelling. Does not address all parts of the writing task. Lacks a consistent point of view and organizational structure. May include marginally relevant facts, details, and explanations.

Lesson Plan Requirements

- **Superior:** Instructional goals and objectives clearly stated. Instructional strategies appropriate for learning outcome(s). Method for assessing student learning and evaluating instruction is clearly delineated and authentic. All materials necessary for student and teacher to complete lesson clearly listed.
- **Standard:** Instructional goals and objectives are stated but are not easy to understand. Some instructional strategies are appropriate for learning outcome(s). Method for assessing student learning and evaluating instruction is present. Most materials necessary for student and teacher to complete lesson are listed.
- **Sub-standard:** Instructional goals and objectives are not stated. Learners cannot tell what is expected of them. Instructional strategies are missing or strategies used are inappropriate. Method for assessing student learning and evaluating instruction is missing. Materials necessary for student and teacher to complete lesson are missing.

Instructor/Student Contact Information

Throughout the course participants will be communicating with the instructor and their classmates on a regular basis using asynchronous discussion forums. Students are provided with instructor contact information in the event they want to make email or phone contact. In addition, students are encouraged to email or phone the instructor at any time. Students will also receive feedback on the required assignments as they are submitted.

Forums

Participation is an important expectation of this course and all online courses. Online discussions promote reflection and analysis while allowing students to appreciate and evaluate positions that others express. While students may not be engaging with the same students throughout this course, they will be expected to offer comments, questions, and replies to the discussion question whenever possible. The faculty role in the discussion forum is that of an observer and facilitator.

Coursework Hours

Based on the Carnegie Unit standard, a unit of graduate credit measures academic credit based on the number of hours the student is engaged in learning. This includes all time spent on the course: reading the textbook, watching videos, listening to audio lessons, researching topics, writing papers, creating projects, developing lesson plans, posting to discussion boards, etc. Coursework offered for FPU Continuing Education graduate credit adheres to 45 hours per semester unit for the 900-level courses. Therefore, a student will spend approximately 135 hours on a typical 3-unit course.
