Visual note taking is one of the best ways to learn and process new information. Sketchnotes for Comprehension is not a course for artists or those who want to become artists. It is a course for those who want to improve or teach others to improve in the skills of taking better notes. Through this course, you will learn the foundations of how to teach your students to take notes that will help them organize and retain information in a fun and powerful way.

## **Grading Policies and Rubrics for Assignments**

- Assignments will be graded per criteria presented in the course grading rubrics.
- Students must earn a minimum of 80% to received credit for the assignment.
- A = 90-100% and B= 80-89%, (anything below 80% will not receive credit.)
- Grading Policies:
  - The discernment between an A or a B is at the discretion of the instructor based on the quality of work submitted (see assignment rubrics).
  - Coursework falling short of a quality equaling a B or a Credit Grade will be returned with further instructions.
  - All assignments must be completed to receive a grade. In addition, all assignments are expected to reflect the quality that teacher-training institutions require of professional

educators. If completed assignments do not meet this standard, students will be notified with further instructions from the instructor.

#### **Writing Requirements**

- Superior: Writing is clear, succinct, and reflects graduate level expectations.
- Standard: Writing is acceptable with very few mistakes in grammar and spelling.
- Sub-standard: Writing contains noticeable mistakes in grammar and spelling.

#### **Discussion Forum Requirements**

- **Superior:** Response was at least 1 page (3 fully developed paragraphs) in length. Thoroughly answered all the posed questions, followed all the assignment directions, proper grammar and no spelling errors. Language is clear, concise, and easy to understand. Uses terminology appropriately and is logically organized.
- Standard: Response was less than 1 page in length (less than 3 fully developed paragraphs).
   Answered all the questions but did not provide an in-depth analysis, followed some of the assignment directions, minor formatting issues, proper grammar and no spelling errors.
   Language is comprehensible, but there a few passages that are difficult to understand. The organization is generally good.
- **Sub-standard:** Response was only ½ page in length (1-2 paragraphs). Did not answer all the required questions and/or statements or responses were superficial, vague, or unclear, did not follow many of the assignment directions or submitted response late, many formatting errors, many grammatical and spelling errors. Is adequately written, but may use some terms incorrectly; may need to be read two or more times to be understood.
