#### Course Description

**Google Certified Educator Level 2** is for students who want to become recognized as GCEL2 certified with expertise in Google applications and how to use the apps to improve student learning. Google for Education created GCEL2, which, in their words, "is for those educators who want to prove that they are advanced users with expertise in the use of Google classroom tools." The curriculum and exam go deeper than GCEL1 in understanding how the apps integrate to enhance learning and productivity. Applications include Documents, Sheets, Slides, Drive, Forms, Gmail, Search, YouTube, Sites, Calendar, Keep, Maps, Earth, Classroom, Chrome, Draw, and Tasks. **Students with a current GCEL2 certificate are not required to take the exam or complete the Advanced Training. Previous GCLE1 certification is not a requirement.**

The Google for Educators website, YouTube tutorials, and online resources provide free online tutorials and support information. The exam, composed of objective test questions and allows online access, is offered through an outside entity at a nominal cost. It can be taken multiple times.

**GCEL2 can be taken for 2 or 3 units.** The third unit has hands-on assignments using Google Apps to create an interactive, individualized curriculum. Docs and Slides are the platforms for creating interactive documents and choice boards. You will learn new skills as you incorporate videos, playlists, phone/tablet images, shared media, hyperlinks, voice recordings, videos, dropdowns, smart chips, templates, and how to share your files with students. This course supports national, state, and local standards and does not require student access. To find out more information about becoming a GCEL2 go online to the Google for Education Training Center.

**Note:** There is no required book for this course.

#### Required Texts and Course Materials

**Exam Fee:** There is a fee to take the GECL2 exam which is administered through a private company that is unconnected to FPU. The current fee is \$25 with additional fees to retake the exam.

**Technology Requirements:** Students will need a computer/laptop capable of running Google applications and recording their voices. If needed, microphones may be purchased for under \$10. Google applications are cloud-based requiring a dependable internet connection with enough bandwidth. Students will need a free Google account.

**Online Resources:** Relevant online resources that support the course content and encourage further investigation will be available for free throughout the course assignments. Active hyperlinks are utilized throughout the course and will link to the appropriate information when clicked. These include videos, podcasts, worksheets, online activities, journal articles, and other resources.

**Canvas:** This course will be delivered totally online. Canvas is a web-based learning management system (LMS) that provides students access to online resources, documents, videos, assignments, quizzes, forums, etc. Canvas is easy to learn and has a user-friendly interface.

## Course Dates

Self-paced; students may enroll at any time and take up to one year, from the date of registration to complete assignments. Students may complete assignments in no less than three weeks for a 3-unit course (one week per unit).

## Grading Policies

- Assignments will be graded per criteria presented in the course rubrics.
- A = 90-100% and B = 80-89%, (anything below 80% will not receive credit.)
- The discernment between an A or a B letter grade is at the discretion of the instructor based on the quality of work submitted (see course rubrics).
- Coursework falling below a B grade will be returned with further instructions.
- All assignments must be completed to receive a grade and are expected to reflect the quality that teacher-training institutions require of professional educators. If completed assignments do not meet this standard, students will be notified with further instructions from the instructor.

## Writing Requirements

- **Standard:** Writing is acceptable with very few mistakes in grammar and spelling. Addresses most parts of the writing task. Maintains a mostly consistent point of view and organizational structure. Includes mostly relevant facts, details, and explanations.
- **Sub-standard:** Writing contains noticeable mistakes in grammar and spelling. Does not address all parts of the writing task. Lacks a consistent point of view and organizational structure. May include marginally relevant facts, details, and explanations.

## Lesson Plan Requirements

- **Superior:** Instructional goals and objectives clearly stated. Instructional strategies appropriate for learning outcome(s). Method for assessing student learning and evaluating instruction is clearly delineated and authentic. All materials necessary for student and teacher to complete lesson clearly listed.
- **Standard:** Instructional goals and objectives are stated but are not easy to understand. Some instructional strategies are appropriate for learning outcome(s). Method for assessing student learning and evaluating instruction is present. Most materials necessary for student and teacher to complete lesson are listed.
- **Sub-standard:** Instructional goals and objectives are not stated. Learners cannot tell what is expected of them. Instructional strategies are missing or strategies used are inappropriate.

## **Instructor/Student Contact Information**

Throughout the course participants will be communicating with the instructor and their classmates on a regular basis using asynchronous posting forums. Students are provided with instructor contact information in the event they want to make email or phone contact. In addition, students are encouraged to email or phone the instructor at any time. Students will also receive feedback on the required assignments as they are submitted.

## **Forums**

Participation is an important expectation of this course and all online courses. Online forums promote reflection and analysis while allowing students to appreciate and evaluate positions that others express. Forum postings are open to be viewed by all students in the course, so do not post sensitive or personal information about your students. While students may not be engaging with the same students throughout this course, they will be expected to offer comments, questions, and replies to the forum questions whenever possible. The faculty role in the forums is that of an observer and facilitator.

## **Coursework Hours**

Based on the Carnegie Unit standard, a unit of graduate credit measures academic credit based on the number of hours the student is engaged in learning. This includes all time spent on the course: reading the textbook, watching videos, listening to audio lessons, researching topics, writing papers, creating projects, developing lesson plans, posting to discussion boards, etc. Coursework offered for FPU Continuing Education graduate credit adheres to 45 hours per semester unit for the 900-level courses. Therefore, a student will spend approximately 135 hours on a typical 3-unit course.
