Course Description

This course, Google Certified Educator Level 1 (**GCEL1**), is for students who want to pass the GCEL1 exam to become certified and want to expand their skills and knowledge on using Google applications to improve instruction, communication, and personal productivity. The organization, Google for Education, created the GCEL1 program. It applies to all teachers and other professional developers working with fellow educators to enhance their skills in using Google tools and applying them to the classroom setting. Certification requires going through Google for Education's online tutorial and passing the GCEL1 exam. The applications covered in this course include Documents, Sheets, Slides, Forms, Sites, Calendar, Search, Keep, Gmail, Chrome, and YouTube. Tutorials and assignments include learning ways to engage students, individualizing instruction, using the flipped classroom instructional model, and teaching digital literacy. You will learn ways to streamline your workflow, improve communication, and use collaborative features in the applications. This course supports national, state, and local standards and does not require a classroom of students.

This course can be taken for either 2 or 3 units. Each topic section is labeled accordingly. The third unit has hands-on assignments using Google Apps, including Calendar, Documents Forms, and Groups. Tutorials and assignments focus on online communication and interactions. These apps will streamline communication, including creating groups, inviting people to events, sharing a calendar, and collaborating on a document.

Note: There are no required book for this course.

Exam Fee: There is a fee to take the GECL1 exam administered through a private company unconnected to FPU. The current fee is \$25, with additional fees to retake the exam.

Online Resources: Relevant online resources that support the course content and encourage further investigation will be available throughout the course assignments. Active hyperlinks are utilized throughout the course and will link to the appropriate information when clicked. These include videos, podcasts, worksheets, online activities, journal articles and other resources.

Moodle: Moodle is a web-based learning management system used to support flexible teaching and learning in both face-to-face and distance courses (e-learning).

Grading Policies

- Assignments will be graded per criteria presented in the course rubrics.
- A = 90-100% and B = 80-89%, (anything below 80% will not receive credit.)
- The discernment between an A or a B letter grade is at the discretion of the instructor based on the quality of work submitted (see course rubrics).
- Coursework falling below a B grade will be returned with further instructions.
- All assignments must be completed to receive a grade and are expected to reflect the quality that teacher-training institutions require of professional educators. If completed assignments do not meet this standard, students will be notified with further instructions from the instructor.

Writing Requirements

- **Standard:** Writing is acceptable with very few mistakes in grammar and spelling. Addresses most parts of the writing task. Maintains a mostly consistent point of view and organizational structure. Includes mostly relevant facts, details, and explanations.
- **Sub-standard:** Writing contains noticeable mistakes in grammar and spelling. Does not address all parts of the writing task. Lacks a consistent point of view and organizational structure. May include marginally relevant facts, details, and explanations.

Lesson Plan Requirements

- **Superior:** Instructional goals and objectives clearly stated. Instructional strategies appropriate for learning outcome(s). Method for assessing student learning and evaluating instruction is clearly delineated and authentic. All materials necessary for student and teacher to complete lesson clearly listed.
- **Standard:** Instructional goals and objectives are stated but are not easy to understand. Some instructional strategies are appropriate for learning outcome(s). Method for assessing student learning and evaluating instruction is present. Most materials necessary for student and teacher to complete lesson are listed.
- **Sub-standard:** Instructional goals and objectives are not stated. Learners cannot tell what is expected of them. Instructional strategies are missing or strategies used are inappropriate.

Instructor/Student Contact Information

Throughout the course participants will be communicating with the instructor and their classmates on a regular basis using asynchronous posting forums. Students are provided with instructor contact information in the event they want to make email or phone contact. In addition, students are encouraged to email or phone the instructor at any time. Students will also receive feedback on the required assignments as they are submitted.

Forums

Participation is an important expectation of this course and all online courses. Online forums promote reflection and analysis while allowing students to appreciate and evaluate positions that others express. Forum postings are open to be viewed by all students in the course, so do not post sensitive or personal information about your students. While students may not be engaging with the same students throughout this course, they will be expected to offer comments, questions, and replies to the forum questions whenever possible. The faculty role in the forums is that of an observer and facilitator.

Coursework Hours

Based on the Carnegie Unit standard, a unit of graduate credit measures academic credit based on the number of hours the student is engaged in learning. This includes all time spent on the course: reading the textbook, watching videos, listening to audio lessons, researching topics, writing papers, creating projects, developing lesson plans, posting to discussion boards, etc. Coursework offered for FPU Continuing Education graduate credit adheres to 45 hours per semester unit for the 900-level courses. Therefore, a student will spend approximately 135 hours on a typical 3-unit course.
