# Earn Continuing Education Credits from Fresno Pacific University for Time Accumulated on the Alludo Platform

Alludo Learning and Fresno Pacific University are thrilled to announce our partnership through which educators have the exciting opportunity to earn graduate-level, semester units of university credit\* for work completed on the Alludo platform.

NON-ALLUDO DISTRICT EDUCATOR - If your school district does not have a license with Alludo Learning, you can still earn graduate-level university credit through our license with Alludo. FPU Continuing Education's Micro-Learning program supports all educators with online, accessible professional development across many topics and skills. With over 2,400 personalized learning activities to select from, FPU Continuing Education provides skills and knowledge training based on the unique learner's needs and interests.

### **Details:**

- One unit of graduate-level university credit is equivalent to 15 hours of Alludo learning time.
- Earn up to 18 units (270 hours of Alludo learning time) each fiscal school year for time spent on the Alludo platform.

Please check with your school or district administrator to confirm that you are eligible to receive credits through the FPU/CE program.

# How it works:

- Register at <u>FPU/CE</u> for the desired number of units. (15 hours of Alludo time = 1 unit)
- Learners can earn up to 18 units each fiscal school year based on the activities approved in Alludo.
- Evidence of learning is required, and is assessed against specified criteria for approval.
- Upon successful acceptance of the evidence, learners will be awarded points and time credit for each Alludo micro-learning activity.
- Time and points earned are visible on the user's Transcript.

### How learners show hours for credit:

- A screenshot of the Alludo Transcript reflecting activities and total time/points must be submitted
  to the FPU course instructor as evidence of successful completion. To find your Transcript, go to
  My Portfolio on the top navigation bar. Click Download Transcript and send a copy or screenshot
  of entire transcript to peggi.kriegbaum@fresno.edu
- Upon receipt, Learners will receive an email from Peggi Kriegbaum when the evidence has been evaluated and the grade posted.

### Additional information:

- Upon successful completion of all requirements, a grade of Credit will be issued; if Learner's district does not accept CR grades, notify the FPU instructor, and a letter grade of B will be issued (CR is equivalent to a letter grade of B).
- If assignments are completed earlier than the due date, submit them to the instructor as soon as completed and your grade will be promptly posted.
- If the assignment is not received on the due date, a grade of NC will be issued. Learners will not receive a reminder of the due date.

Learners will be able to view their grade(s) and order a transcript by logging in to the <a href="CE website">CE website</a> (https://ce.fresno.edu/) and clicking on My Account, then View my Courses, Final Grade Report and Order Transcript.
