Course Description

Geology and the earth science have now become core curricular topics for the new generation of integrated science standards. Yet, the principles of the earth sciences—ideas that deal with vast stretches of both landscape and time—are hard for our minds to grasp. Many teachers continue to feel underprepared to teach these topics and seek to bolster their understanding of the earth sciences.

Presented in a phenomena-based, 3-D curricular format, Practical Geology is designed to teach the major principles of the earth sciences using examples from everyday life. These examples can be incorporated into any classroom setting so that students can easily recognize these geologic principles at work.

Delivered from the perspective of a lively lab setting with many visual aids, this course is highly engaging and practical. Teachers of all grade levels will find valuable understanding, insight, and material throughout this course. This course provides the foundational background necessary to fully understand what are often seen as mysterious geologic processes.

Required Texts and Course Materials

Required book is included in the course fees and can be downloaded from the course Moodle page.

Online Resources: Relevant online resources that support the course content and encourage further investigation will be available throughout the course assignments. Active hyperlinks are utilized throughout the course and will link to the appropriate information when clicked. These include videos, podcasts, worksheets, online activities, journal articles and other resources.

Canvas: This course will be delivered totally online. Canvas is a web-based learning management system (LMS) that provides students access to online resources, documents, videos, assignments, quizzes, forums, etc. Canvas is easy to learn and has a user-friendly interface.

Course Dates

Self-paced; students may enroll at any time and take up to one year, from the date of registration, to complete assignments. Students may complete assignments in no less than three weeks for a 3-unit course (one week per unit).

Instructor/Student Contact Information

Throughout the course participants will be communicating with the instructor and their classmates on a regular basis using asynchronous posting forums. Students are provided with instructor contact information in the event they want to make email or phone contact. In addition, students are encouraged to email or phone the instructor at any time. Students will also receive feedback on the required assignments as they are submitted.

Forums

Participation is an important expectation of this course and all online courses. Online forums promote reflection and analysis while allowing students to appreciate and evaluate positions that others express. Forum postings are open to be viewed by all students in the course, so do not post sensitive or personal information about your students. While students may not be engaging with the same students throughout this course, they will be expected to offer comments, questions, and replies to the forum questions whenever possible. The faculty role in the forums is that of an observer and facilitator.

Coursework Hours

Based on the Carnegie Unit standard, a unit of graduate credit measures academic credit based on the number of hours the student is engaged in learning. This includes all time spent on the course: reading the textbook, watching videos, listening to audio lessons, researching topics, writing papers, creating projects, developing lesson plans, posting to discussion boards, etc. Coursework offered for FPU Continuing Education graduate credit adheres to 45 hours per semester unit for the 900-level courses. Therefore, a student will spend approximately 135 hours on a typical 3-unit course.
