Course Description

This self-guided standards-based course is designed to provide participants a first-hand experience with Eastern Sierra mining camps showing how the demand for gold and silver affected the history and development of the West. Bodie is probably the best-preserved example of a western mining ghost town. Now protected and managed by California State Parks, Bodie's history is well documented and the town is maintained in a state of arrested decay. It's also a photographer's paradise. The visitations and course materials will guide students through the history of the gold and silver rush providing them with information and experiences which coordinate with the Common Core State Standards for English, language arts and literacy, in history/social studies and science. Experiences and knowledge from the course can be included in classroom lessons or comprehensive thematic units providing a meaningful experience for students and a foundation for potential field trips. Options are available for customizing course requirements to better-fit individual teacher needs; contact the instructor for details. Travel to Bodie is on a dirt road, which can be difficult to impossible during winter months; other sites are open year-round. A non-travel option is available; contact the instructor for details.

Grading Policies

- Assignments will be graded per criteria presented in the course rubrics.
- A = 90-100% and B = 80-89%, (anything below 80% will not receive credit.)
- The discernment between an A or a B letter grade is at the discretion of the instructor based on the quality of work submitted (see course rubrics).
- Coursework falling below a B grade will be returned with further instructions.
- All assignments must be completed to receive a grade and are expected to reflect the quality that teacher-training institutions require of professional educators. If completed assignments do not meet this standard, students will be notified with further instructions from the instructor.

Instructor/Student Contact Information

Throughout the course participants will be communicating with the instructor and their classmates on a regular basis using asynchronous posting forums. Students are provided with instructor contact information in the event they want to make email or phone contact. In addition, students are encouraged to email or phone the instructor at any time. Students will also receive feedback on the required assignments as they are submitted.

Forums

Participation is an important expectation of this course and all online courses. Online forums promote reflection and analysis while allowing students to appreciate and evaluate positions that others express. Forum postings are open to be viewed by all students in the course, so do not post sensitive or personal information about your students. While students may not be engaging with the same students throughout this course, they will be expected to offer comments, questions, and replies to the forum questions whenever possible. The faculty role in the forums is that of an observer and facilitator.

Coursework Hours

Based on the Carnegie Unit standard, a unit of graduate credit measures academic credit based on the number of hours the student is engaged in learning. This includes all time spent on the course: reading the textbook, watching videos, listening to audio lessons, researching topics, writing papers, creating projects, developing lesson plans, posting to discussion boards, etc. Coursework offered for FPU Continuing Education graduate credit adheres to 45 hours per semester unit for the 900-level courses. Therefore, a student will spend approximately 135 hours on a typical 3-unit course.
