Course Description

Integrating Artificial Intelligence (AI) into teaching may seem overwhelming, especially with concerns about complexity, cost, and ethical implications. The course aims to simplify this process, offering educators a straightforward, practical resource. It is designed to help teachers navigate the world of AI with ease, addressing common fears while showing how AI can enhance, rather than replace, the human elements of teaching.

This course breaks down AI in a jargon-free manner, making it accessible to educators of all technical skill levels. It provides step-by-step instructions for integrating AI strategies into daily classroom practices, offering real-world examples of successful AI implementation in schools worldwide. Ethical concerns are tackled with thoughtful strategies for responsible AI use, ensuring that educators can adopt these tools without compromising student trust or equity.

Educators will find detailed modules on how AI can streamline administrative tasks and reduce workloads while enhancing the learning experience. AI's ability to personalize education is highlighted, allowing teachers to tailor lessons to individual students' needs and create more engaging, dynamic learning environments. The course also offers practical tips for finding affordable AI tools, crafting effective AI prompts, and overcoming resistance from colleagues hesitant to adopt new technologies.

This course explores how AI can increase access to educational resources for all students and presents frameworks for using AI in various subjects. Educators will also learn how to avoid common pitfalls in AI use and discover emerging trends in AI's role in education. AI can transform today's classrooms and this course will empower educators to take the first step toward integrating AI in a way that enhances student learning, boosts engagement, and maintains the invaluable personal connection between teachers and students.

Instructor/Student Contact Information

Throughout the course participants will be communicating with the instructor and their classmates on a regular basis using asynchronous discussion forums. Students are provided with instructor contact information in the event they want to make email or phone contact. In addition, students are encouraged to email or phone the instructor at any time. Students will also receive feedback on the required assignments as they are submitted.

Forums

Participation is an important expectation of this course and all online courses. Online discussions promote reflection and analysis while allowing students to appreciate and evaluate positions that others express. While students may not be engaging with the same students throughout this course, they will be expected to offer comments, questions, and replies to the discussion question whenever possible. The faculty role in the discussion forum is that of an observer and facilitator.

Coursework Hours

Based on the Carnegie Unit standard, a unit of graduate credit measures academic credit based on the number of hours the student is engaged in learning. This includes all time spent on the course: reading the textbook, watching videos, listening to audio lessons, researching topics, writing papers, creating projects, developing lesson plans, posting to discussion boards, etc. Coursework offered for FPU Continuing Education graduate credit adheres to 45 hours per semester unit for the 900-level courses. Therefore, a student will spend approximately 135 hours on a typical 3-unit course.
